The Office of the Governor of Guam, by and through the Office of the Attorney General, hereby submits this clarification and acknowledgment of receipt of notice of the appeal recusal in OPA-PA-22-004The Procurement Officer for Request for Proposals RFP-Office of the Governor of Guam-2022-001 ("RFP") is Venido Torres. It appears that the notice of appeal required pursuant to 2 GAR, Div. 4 §

12104(c)(1) was inadvertently addressed to Matthew Santos, who is the RFP's designated single point

of contact for vendors and potential vendors in the underlying procurement. Venido Torres hereby

acknowledges receipt of the notice of appeal and recusal of the Public Auditor in OPA-PA-22-004, as

the Procurement Officer for the RFP, and attaches his initialed, stamped, and dated acknowledgement

of the cover pages to this filing as Exhibit A, as requested by the Office of the Public Auditor.

Additionally, 2 GAR, Div. § 12104(c)(1) requires that "[t]he Appellant shall file a copy of the

Appeal, and all supporting documents with the Chief Procurement Officer, the Director of Public Works,

or the head of a Purchasing Agency within 24 hours of filing of said Appeal with the Office of the Public

Auditor." Id. The Appellant did not provide a copy of the appeal or supporting documents to the Office

of the Governor. Today, the Office of the Governor obtained access to the appeal and supporting

documents from the posting on the website of the Office of Public Accountability, but reserves its rights

to move to dismiss the appeal and request any other remedies or relief based on the Appellant's failure

and delay.


