Pursuant to 2 GAR Div 4, Chap 12, §12104(3), please submit one complete copy of the procurement record for each of the procurement solicitations above, as outlined in 5 GCA Chapter 5, §5249, to OPA by **Wednesday**, **April 5, 2012**, five work days following receipt of this notice of appeal; and one copy of the Agency Report for each of the procurement solicitations cited above, as outlined in 2 GAR Div 4, Chap 12, §12105, by **Thursday**, **April 12**, **2012**, ten work days following receipt of this notice of appeal.

When filing all other required documents with our office, please provide one original and two copies to OPA, and serve a copy to the Appellant (protesting vendor). OPA respectfully asks that GSA provide one original and two copies of the procurement record as the Guam Procurement Law and Regulations require only one copy. The three procurement record copies requested by OPA are distributed as follows: Copy-1: Master File; Copy-2: Public Auditor; and Copy-3: Hearing Officer.
