The hearing for this Appeal reconvened on December 18, 2012, at the Hearing Room of the Office of Public Accountability in Hagatna, Guam. Present were Public Auditor Doris Flores Brooks and Hearing Officer Phillip Torres. Attorney Jacqueline Terlaje was present for the Appellant, Data Management Resources ("DMR"); and Sandra Miller, legal counsel for the Governor of Guam, was present for General Service Agency ("GSA"). Benjamin Abrams and John Weisenberger were present on behalf of the Attorney General.

Before evidence was presented at the hearing, DMR's counsel orally moved for a continuance. She requested the continuance in order for an opportunity to seek relief in the

Superior Court of Guam related to the settlement of the present Appeal. The continuance was granted, in the interest of promoting the integrity of the procurement process.

It is therefore ORDERED that the December 18, 2012 Procurement Appeal Hearing shall be continued. The hearing shall recommence on December 27, 2012, at 9:00 a.m., at which time parties shall be resume presenting evidence in the present Appeal, unless Appellant DMR withdraws the Appeal before that time, or the Superior Court of Guam validly exercises its jurisdiction to stay the proceedings, or this matter is settled.
