On May 21, 2012, DATA staff discovered that an interface program was removed from the system. This is a program that transfers data from Department of Administration to Department of Revenue and Tax. This would have completed the process of the payments making it to the DRT tax files. In a phone conversation from Joey Manibusan to Richard Taitano today, he stated that this was part of the POS and they turned it off. This program would have been turned off between May 15 and today.

I don't agree with their assertion and it doesn't seem right and proper that they could just access the system and yank the program as they see fit. I need your assistance in determining what right does DMR have to do such action without informing the government.


I am also attaching a copy of an old contract that supposedly GSA uses to issue purchase orders for maintenance of the AS400. It is an annual maintenance of \$400,000 per year. They have 24 hour access to the system from their place of business. This I believe is a serious issue as they have access to all the financial information, and have an unfair advantage over other vendors since they see all the financial records.

A major event occurred last Monday, May 21st, 2012, that involves financial interaction between our departments, the Department of Administration (DOA) and the Department of Revenue and Taxation (DRT).

DOA was surprised to learn that a key software program that allows a critical interface between the DRT and DOA was suddenly removed from the DOA Financial Management System (DOA-FMS).

The DOA considers that the software program, upon which the DRT-DOA interface depends, belongs to the Government of Guam under our "2003 Software Maintenance Contract" No. C020600631 and "2004 Contract for Services for the Government of Guam through the Department of Administration and the Department of Revenue and Taxation Contract" No. C0406U0020, and should have never been removed or disabled.

We respectfully request that you restore the software program immediately to avoid further costly disruption of our Government of Guam functions.

We have a longstanding relationship between your company, the Data Management Resources LLC, and the Government of Guam and we are hopeful that we can resolve this matter expeditiously.

Re: AS400 Maintenance Contracts with DRT/DOA

Thank you for your prompt reply to my letter. I appreciate your responsiveness.

For the 20 years DOA, DRT and DMR have been working together to build, maintain, and operate the financial and tax systems, we have reported problems to DMR and you and your staff have diagnosed the problem. You determined the cause(s) of the problem, recommended solutions, let us know whether you considered the solution was a maintenance issue or an enhancement, and then implemented the solution we agreed would resolve the problem. As you are well aware, neither the DOA staff nor the DRT staff is capable of diagnosing system problems. Our lack of skills is the main reason DOA has had a \$400,000 per year maintenance contract and DRT has had a \$720,000 per year maintenance contract with DMR for all these years plus a \$150,000 per year support agreement.

This problem, passing payment data from the DOA financial systems to the DRT systems and having it appropriately allocated to the correct tax records has been brought to DMR's attention previously. I am requesting again that DMR diagnose the problem and let me know whether you think the solution falls under the maintenance contract or is an enhancement. If you think it is an enhancement, please let me know what needs to be done and the estimated cost.

Given the mission critical nature of this problem, I respectfully request that you get back to me by close of business today, August 3, with a response. I realize this is a very short response time, but the Government of Guam and all of our taxpayers are suffering from the consequences of this problem.

Okay. I think Mr. Villaverde's concern, if I may, and correct me if

I'm wrong is: in order, for example, any software that they use to provide to the Governor's Office or for the use of the government will be able to interface as is required by the spees. Am I correct?

Ernest Villaverde/

BOG:

Mr. Villaverde was alluding to asking if the government would be

providing the vendors/offerors details of the existing supplications / software/programs so that they could get a better understanding

of what it is they are trying to accomplish with this RFP.

Claudia S. Acfalle/CPO/GSA:

Actually, we can't respond to that. You understand that we don't own it. The government doesn't own the existing. So that is why we're putting out this RFP. If you notice there's an Option 1 and an Option 2, because we do want to own it in the future. Okay? So it doesn't, to me, it's irrelevant about the existing, because it's, you know, whoever is successful. This will fade away. So, everything in this proposal is what we want the POS to accomplish, or whatever the offer is, so these are the supplications that we require, because the current is only a lease.

Tom Ashe/

Gov's Ofc/BIT:

Do you know that definitively? Or is that your understanding?

Claudia S. Acfalle/

CPO/GSA:

I think that it's definitive that it is under lease. It's not ours. It's

not ours.

Ernest Villaverde/

BOG:

So with that, then, so are we able to ask the details on it?

Claudia S. Acfalle/

CPO/GSA:

On the current?

Ernest Villaverde/

BOG:

Yes.

Claudia S. Acfalle/ CPO/GSA:

I believe everything. Right. No. No. This is what we needed to focus on. Yes. This is what we need to focus on; so like we said the existing don't belong to us. So that is what we can want the offers to Office of the Governor on the POS system; because the existing doesn't belong to the government.

government So I think what Ernie is trying to touch on, I'm sorry, Josephine Mariano. Bank of Guam, I guess what we're alluding to is, if the government doesn't own anything, so in essence, you're

starting from scratch. Correct? On this.

Claudia S. Acfalle/

CPO/GSA:

Yes.

Mariano/BOG: So we, is it our understanding that we're not going to worry about

existing reports, and existing data that needs to be interfaced, um, if there's really nothing in the backbone that the government owns,

that

CPO/GSA:

You have to set it up.

Josephine

Mariano/BOG:

We set it up.

Claudia S. Acfalle/

CPO/GSA:

Yes, it's required in the audits to provide the report.

Ernest Villaverde/

BOG:

Okay, then that's the reason why I'm asking for clarification. Because there's a, in the specification it says that the offer has to already work, the solutions that the company offer has to already work, again, is that my understanding? Or we can provide a solution, you know, that meets with the requirement? You know, I mean this is an awesome task, you're asking for a solution

immediately to be interfaced.

Claudia S. Acfalle/

CPO/GSA:

No, no, no. The offeror has 120 days upon the award of the contract. Yes, yes, yes, that is fine. Understood, yes. The opportunity will be afforded the successful offeror ample time, in order for you to be able to interface with the FMS system of the governor's office. Okay, so that will give you enough start right away.

Ernest Villaverde/BOG:

And this is 120 days, minimal to complete all that.

Now going back to my question previously, can we get the details of the FMS?

Claudia S. Acfalle/ CPO/GSA:

I'm pretty sure we can actually provide the mechanisms to interface, but the RFP requires us to interface. So, we have to be able to provide you what's existing in order for you to know what you're interfacing. So, if you, remember the questions that you're raising, to present to the commission, that you do put them in writing, in formal, and so we can have a better understanding. So that we can like retract what the questions are; we will also, because it's being recorded, but it's for a written statement, a requirement for the regulation that everything is put in writing. Okay? But with that being said, yes, we will have to provide you the existing so you'll know what you're interfacing; at that level of, not actually the heart of the system, but just the beginning interfacing part.

Richard Taitano/ DMR:

Just in line with basically on regarding the 120 days. So, the government expects for the entire system we know to be run, once upon signing the contract, the 120 days roll on?

Claudia S. Acfalle/ CPO/GSA:

That's correct.

Richard Taitano/ DMR:

Okay, and then again, my second question, thanks for the clarification. My second question on page 16, 1.4.32 – okay, the government is asking to own the control of the software, correct? Okay, but we have something in conflicting here if you look at 4.6.1. You have the software requirements here. And it seems to be in conflict with that 1.4.32. Now, and uh, but just to clarify even beyond that, I just want to make sure that the government is actually not uh, not treating the other vendors, actually to treat the other vendors the same, basically.

Now, if it is a requirement for the government to own the source code; I'm a software company, I make my living on software, developing software, that's pretty much my property, right. But, if the government wants to own it and freely distribute it free of use by anyone; I don't know a software company that does that today, but if the government actually requires Microsoft to do that or any

other software you purchase to use within the government, that they own the source code, then so be it. But in this case, I cannot even agree to that part.

Tom Ashe/ Gov's Ofc/BIT:

I think we need to clarify that a little. What we're looking at is, and what we're looking at is, if you're selling a commercially available product that is something like a Word or a Windows or if you have a Shrink Wrap POS System that you're selling to us, and that, you know, that is a commercial product, that's yours; and we're purchasing the license for it and we refer to that as in our, as commercial software. But if you're writing something custom that's just for the government of Guam, that's government of Guam's.

Richard Taitano/ DMR:

Okay.

Tom Ashe/ Gov's Ofc/BIT:

And so what we're looking at is, we don't want something where we collaborate and we need to add one more transaction type – Oh! That's uh, we're gonna have to set up another bid and an RFP and we have to have an additional purchasing here. We're looking to make things accessible. So if we're not, if we come up with another transaction type, you know, well let's just purchase one, or if we need to add another type of payment system, you know, a new marketable status. You know, things look extensibly, you know, we've had systems where because it was proprietarily owned by the vendor, you know, things just disappeared; and suddenly we have documents, thousands of documents that were scanned that suddenly, agencies don't have access to.

It's the people's. It's a lot for the people. And we want to make sure that we can run the government and not be tied into something that is proprietary. And the software, you know, the Brown Trap or bus scenario, if you, maybe you see the developer, and you own it, and you have to leave us tomorrow, where does that leave us?

... As being able to work operationally, working any type of maintenance?

Richard Taitano/ DMR:

So, if I can prove that my software is actually being used commercially elsewhere, would that apply to me?

Tom Ashe/

Gov's Ofc/BIT:

The, and again, I think we clarified that if it's being used elsewhere commercially, and that portion with the intellectual property owned by you, anything that's like configuration files or anything that were custom done to that, like, let's say you have a core system and if there's custom pieces that are done that are specific to GovGuam, then those pieces will be owned by GovGuam, and are licensed to your core system.

Richard Taitano/ DMR:

Okay. Then what we gotta do then, with that being said, the only objection I have to that part, is the fact that basically – free for all to use. You know, when we develop things, we do things, you know, that's our intellectual property; that's how we make our living; now, if everyone is just able to go out there and use it – free will without any discretion or controls, that's not right.

Tom Ashe/ Gov's Ofc/BIT:

Now, where do we say that.

Richard Taitano/ DMR:

1.4.32 – the last sentence: "Ownership rights will recognize and provide that all agencies of the government reserve royalty-free, non-exclusive, and irrevocable license to provide, publish or otherwise use and to authorize others to use all system code and documentation which is required or produced as a result of the contract."

Basically, you can authorize anyone to use it.

Tom Ashe/ Gov's Ofc/BIT:

Okay, uh, we need to drop that out with the other section there. I think we'll have two (2) separate riders on that section and the one that you mentioned with that specification.

The intent is, is that things that are custom done, that really only apply to GovGuam, should be owned by GovGuam. That's the intent. And that after, it's free to use within the government of Guam.

If you have something that's typed specifically to, you know, some table that's in our Financial Management System, that only applies to GovGuam, you know, it doesn't make sense that it's not our property. And also, we want loss of API's, we want the block bit, you know, this configuration will make it expensible here, we've got the cables, we add another row, that way there isn't something that's tied into the co-phase as much, so it allows it to grow, if it needs to grow.

Claudia S. Acfalle/

CPO/GSA:

We'll address that.

Richard Taitano/

DMR:

I appreciate that.

Ernest Villaverde/

BOG:

So that clause that was mentioned, does that supersede, like the NDA non-disclosure or anything? Or, essentially if some business is in breach with the government, certainly you guys send some non-disclosure, would that be applicable? Or that clause would supersede that or make that moot.

I'm supposing in respect to intellectual property. Richard may allude to that instrument because, in any business engagement, effectively we protect our intellectual property; and to protect that, and it may be enforceable, it may be not be challenged through a non-disclosure form.

Tom Ashe/

Gov's Ofc/BIT:

I guess I'm not sure how that applies to that. I mean, if you are entering into a license with another company and you already have software again that's already commercially available, and that NDA exists in commune for that federal regulation?

Ernest Villaverde/

BOG:

I don't know what the engagement is with the government of Guam, but it's just, what is the process that applies to the Bank of Guam, is it NDA?

Tom Ashe/ Gov's Ofc/BIT:

I can't answer that, Claudia, can you answer that?

Ernest Villaverde/ BOG:

Do we sit down and? We have our own requirements with respect to, you know, like what Richard mentioned, intellectual property, privacy, things like that. Why just keep thinking that there are two parts, and typically when the plan is engaged, that form is in place.

Claudia S. Acfalle/ CPO/GSA:

Mr. Villaverde, if I may, you're correct, as long as you identify on your proposal that you submit, which ones are gonna need the proprietary protection.

Tom Ashe/ Gov's Ofc/BIT:

Sure. It goes to say that we all want to protect, and certainly don't want people to publicly know what the scheme of the Financial Management System is. So we certainly would need to have certain esteem sharing depending on how things are going to be interfaced. At the same time, what we want are more sensibilities, more APIs, or message brokerage, or something like that. So, you know, if there's a, for example, something on the system that you're gonna provide that provide an API so that some other future system can then hook into it, you know, it can't be that if an NDA issue or some other vendor comes down the line with some other bid can not now talk to your system because of the NDA. Does that make sense?

Ernest Villaverde/ BOG:

Yeah. Thank you sir.

Tom Ashe/ Gov's Ofc/BIT:

Yeah, there are areas that we need to expose so that the system can interface and then there's other parts that we don't need to have that happen.

Dawn Erwin/BOG:

Given that, relative to the AS400 and the requirements in the RFP for Real Time Transactions, or Real Time Interaction, with the FMS accounting task catastrophe systems, will you be able to provide a network infrastructure and for in the event the RFP responds for the formulation of the fruition offering and you know, if so, we are alluding to the fact that the specific component once be in the realm of the, you know, can it be provided without the NDA or will it require?

Tom Ashe/ Gov's Ofc/BIT:

Uh. let's see... Why are you looking at me? (laughter)

Claudia S. Acfalle/ CPO/GSA:

Because the RFP requires the interfacing with the existing FMS, I believe that we're going to be allowed to interface.

Tom Ashe/ Gov's Ofc/BIT:

Well we have to, what we need to, what we want it to do is have some type of test system that has some type of dummy data in it because we don't want to expose our current, live, production system, you know; you know, financial and personnel data through the system that's being tested.

Claudia S. Acfalle/ CPO/GSA:

Yes, so the answer is yes. We will have to provide you some kind of mechanism or information in order for you to identify or realize that your system you're offering is able to interface with our agency FMS, because it's required in the RFP; and we will respond to you.

Dawn Erwin/ BOG:

In addition to what was asked recently about the ownership of the software, as applicable to hardware, what type of hardware is used today and it was mentioned in the RFP about the NFC, is the POS provider of the solution's offer is expected to include hardware provision or specifically an NFC hardware provision?

Tom Ashe/ Gov's Ofc/BIT:

We're not looking at NFC as being implemented within this solution, but what we're looking at is that, things like NFC or any other technology that comes along should be something that could be added on to the system, and not, oh, our NFC system doesn't support that, and then we have to write another one from scratch. But what we're looking at is something indispensable, so as new technologies might come along, and you know, we can't future proof everything, but the idea is that if it's designed appropriately, you're gonna have to plug in some modules which you can drop in to start adding in different functionalities as it comes along in the future. That's what we're looking for.

Dawn Erwin/ BOG:

Anything specific to the actual devises, computers, and whatever where the POS software exists. Is that equipment hardware owned by the government?

I was asking whether the hardware, equipment, computers, or whatever it may be that is not necessarily a component of the software solution of the existing POS today, is that hardware

equipment owned by the government?

Benigno Camacho/ DOA Systems Program

Administrator:

No. The only, just the workstations at the cashier's level; but the

server and the processor that does that thing is not owned by the government. But the actual workstations where you do the work,

that belongs to the government

BOG:

So, basically a dumb terminal.

Benigno Camacho/ DOA Systems Program

Administrator:

Their workstations are PCs. Yeah, but are you talking about the

servers that's processing the PO?

Dawn Erwin/

BOG:

All hardware.

Administrator:

Okay then you're talking about servers. Yeah, that's not even in

our side, that's the vendor's responsibility.

On page 26. Section 4.3.3 under your heading: Transaction Processing, right to the second to the last bullet point, it says, "Be able to receive payments of mixed types,". Now would that apply to a single invoice transaction only? Or does this allow for payments of multiple invoice transactions as well? Uh, you know, well, so, what we need to know is, let's say Γ m a tax-payer and Γ m going to be paying two different tax types in the government, okay. Now, this is what Γ m gonna tell you, when you say mix payments, you mean that the tax payer can rather use cash and check at the same time for that one transaction?

Elaine Fejarang/ DRT:

Yes. Because sometimes they'll say they can only run so much on their credit card right? And then the rest let's say on their cash card, and so right now, what we're doing is, we're processing whatever their credit card can be, or, let's rephrase it, not credit card. Let's do check and cash - they write checks for this much and the rest in cash, so if we get a check we have to process whatever that payment is and whatever year it is, even though we have two years in warranty, and we run that check and then go back out and come back in and run it as a cash portion. So we want to be able to do is go ahead and key in those two years as one and put one as cash and one as check.

Richard Taitano/ DMR:

Okay, then how do you perceive the system handling a bounced check? And, because now you have a mixed payment type for one receipt.

Elaine Fejarang/ DRT:

Well, see when we key in the checks, right, and then we scan that. That's why we want to scan that check.

Richard Taitano/

No, I understand. But how would this, I mean, but basically, it's the handling of that transaction. You have one receipt number with two mixed payment types. You see what I'm saying?

Elaine Fejarang/ DRT:

Uh hmm

Richard Taitano/ DMR:

Instead of running two transactions, you know, two separate transactions, one cash, one check, fine, but now you're having one transaction and two different payment types. That's gonna create an issue especially when you have bounced checks.

Benigno Camacho/ DOA Systems Program Administrator:

The way I'm looking at it, and correct me if I'm wrong, is that we're gonna have the capabilities to do a Type A payment and a Type B payment. Now, if that payment is a credit card or that payment is a check and the check bounced, hopefully the system should be able to determine if funds availability, if not, and there's no funds there, then it should default – there's no funds; and then they'll make their decision. But I don't, the way, the way I'm thinking, is they're gonna accept the check, right? And they're gonna accept the cash and accept it, okay? Now if there's mechanism on the back sling that says to be validated and if that was rejected for whatever reason, then they need to alert the cashier so they can do whatever, further, such type, I'm sorry we can't accept the check; but we want that capability to do both. Type A and Type B at one streak.

Richard Taitano/ DMR:

Okay, based on what you just said earlier then, so what you want is, you want the POS maybe to determine if the check that's

written has available cash.

Benigno Camacho/ DOA Systems Program

Administrator: If the feature has that capability.

Richard Taitano/

DMR:

Do you want this right away?

Benigno Camacho/ DOA Systems Program

Administrator:

If the capability and the feature is there. Okay.

Mariano/BOG:

You know further to that, the banking industry is not that fast.

When you say directly - it has to go thru our network. Okay?

Are they, just for enrichment, Ben, so the DRT system is different

Yes. It's an 825, it's the same machine, but there are two different

machines. To be frank with you, it's supposed to be a redundant system; but we haven't done that yet. It's sad for me to say so. But

our's is better than DOA's. Just kidding.

The other question that I have is on the POS workstation. Is it a requirement on this RFP that if the server goes down, that DOA or in fact, are these POSs supposed to still receive payment? 'Cause

there's a lot said throughout about the uptime regardless of the

network failures.

DRT:

Can you repeat, please?

Kathy Diaz/

DMR:

In the case where, maybe with the network failure that you cannot communicate with DOA or with Rev & Tax; are the POSs still supposed to be up and running and able to accept the payments.

Elaine Fejerang/

DRT:

Yes.

Richard Taitano/

DMR:

That goes along back with the same question that I asked earlier regarding that, here, you have a POS that's out there going to a central location with data from the government; if the government network goes down, that's outside the responsibility of the vendor.

Benigno Camacho/ DOA Systems Program

Administrator:

Here's the thing, in the event the network goes down, we move to manual mode. Okay? We move to manual mode. If the POS can be designed for them to be keyed in manually, instead of them

riding the machine.

Kathy Diaz/

DMR:

Sorry. Can you repeat that again?

Benigno Camacho/ DOA Systems Program Administrator:

In the event for whatever reason the network goes down, the AS-400 goes down, we're gonna need the information, okay? We're gonna do things manually, Okay? So, to eliminate the manual receipt, we want the POS to do a manual transaction, and then later on, capture it. Auntie Rose (Fejeran), am I correct to say that?

Rose Fejeran/ Treasurer/DOA:

Yes, on the AS-400, we need to go in and post manually, but still be able to interface into the regular NOA.

Benigno Camacho/

DOA Systems Program Administrator:

So the POS will capture the manual transaction, and later on we'll process it; in the event, for whatever reason, needed information is down. Okay? We do the same thing at traffic court. We cannot

stop the processing. So we just go manually. Same concept.

Davis Cruz/ DMR:

Are you expecting the POS servers that are posting of any of the specific agencies likely to be in germane as well? Because if you

are, then they will be down too as well.

Administrator:

That's up to the vendor. Okay, if the vendor wants to put it at our network, it's available. If you want to put it in California, then you

take care of the connection. It doesn't matter where the server is.

Davis Cruz/ DMR:

If you're dealing in California, if you're network is down, then we

won't have any connection here.

Tom Ashe/

Gov's Ofe/BIT: Our network is taking a beating here. Our primary DNS server

was at 200; and we're less than 100 now. We're gonna need a lot of support pretty soon. A lot of our issues have been DNS related. We are in fact DNS imbalanced, on the internal side, but externally we've done a lot to address it. We are doing things to move

forward to improve the GGWAN Network.

Benigno Camacho/ DOA Systems Program

Administrator:

Where you put your server, is your call.

Davis Cruz/

DMR:

The only reason why I asking is (the recording becomes garbled) ... if our servers are located in the same areas and the network goes down. We can't communicate.

Benigno Camacho/ DOA Systems Program Administrator:

Okay. If the network goes down, then it's our fault. But if the network goes down because it's your fault and you need to get, it's not my problem, get it up. If it's the government's fault, then we'll understand. We'll penalize you, but you'll not penalize us.

Elaine Fejeran/ DRT:

It's like taxes.

Tom Ashe/ Gov's Ofc/BIT:

If you're at a restaurant, your network goes down, you'd still like to be able to order your meal and make your payments. It's the same thing. We'd still like to handle as much of the transaction at the endpoint as much as possible and then reconcile when the link comes back up. But of course, there might be some reconciliation issues at that point because we couldn't get the server going. But as much as we can, we'd like to keep the process going at the endpoints, would be great.
