

I, Bryan J. Cruz, an Investigator with the Office of the Attorney General, Civil/Solicitor's Division, hereby declare the following:

From 01 June to 17 June, 2012, I was on active duty with the U.S. Air Force Reserves and not available to the Office of the Attorney General to prepare and submit this declaration.

On May 15, 2012, I obtained a government owned iPad belonging to the General Surplus Agency (GSA) Chief Procurement Officer, namely, Claudia Acfalle. This device was reported to have been utilized to record meetings conducted at GSA in regards to the Procurement Record referenced as RFP/DOA-014-11, inclusive of e-mail communications.



I only discovered (2) two audio/video files on the government owned iPad that related to

RFP/DOA-014-11:

1) The first audio/video file was a meeting of the Evaluation Committee that had taken

place before RFP/DOA-014-11 was publicly announced.

2) The second audio/video file was a meeting of the Evaluation Committee inclusive of

Data Management Resources, LLC(DMR) representative, Richard C. Taitano, which took

place following the Government's First Counter Offer.

On May 22, 2012, GSA provided additional discovery, inclusive of each Evaluation

Committee members individual folder contents and a flash memory drive, a.k.a., Thumb-drive.

No handwritten notes were located within each of the committee members folders. The Thumb-

drive contained a total of (6) six audio files, identified as:

1) POS MTG- this file is the same as the first audio/video discovered on the government

owned iPad.

2) POS MTG 2- this file is the same as the second audio/video file discovered on the

government owned iPad.

3) POS REC RCA DEV LTR A- this file is audio recording of the Mandatory Pre-

Proposal Conference, which is barely audible.

4) POS REC RCA DEV LTR B- this file is an unrelated audio file.

5)POS REC RCA DEV LTR C1- this file is a recorded meeting of

the Evaluation Committee discussing Bank of Guam questions relative to RFP/DOA-014-11.

Evaluation Committee discussing DMR questions relative to RFP/DOA-014-11.

On May 23, 2012, I interviewed subject matter experts in the field of computers who

informed me that the Fiber Optic cables connected underground between DMR and the

GovGuam central data facility, located next to the Hagatna Police Precinct, is a high bandwidth

(gigabit velocity) glass fiber cable that can provide DMR with high speed data transmission and

continuous uncontrolled, unrestricted access to the GovGuam data center, enabling DMR to read

and copy nearly all GovGuam line Agency data including stored finance balances, accounts,

communications, contracts, purchase orders and payment records. I was also informed that this

Fiber Optic cable could allow DMR to move, manipulate, alter, delete and otherwise edit vital,

confidential and sensitive GovGuam data, digital records, accounts, etc.

On May 28, 2012, I obtained copies of (4) four GSA employee computer hard drives,

namely:

1) Claudia Acfalle, a.k.a. "Chief"- GSA Chief Procurement Officer ***

2) Anita Cruz- GSA Buyer Supervisor

3) Euphrasia Lujan, a.k.a. "Frasia"- GSA Staff

4) Marissa Leon Guerrero- GSA Staff

***(Ms. Acfalle had (2) two separate computer hard drives that were copied)
