About the Bureau


The Bureau of Statistics and Pans (BSP) is a staff agency to the Office of the Governor. Other public laws and Governor's Executive Orders granted additional roles to BSP such as providing administrative support to the Guam Developmental Disabilities Council (GDDC) and providing a preliminary Business Sector Disaster Damage report to the Governor in the aftermath of a Typhoon.

The Bureau is dedicated to providing expediency in all of its endeavors and in promoting the welfare of the community. Bureau staff are professional in their field of work and dedicated to ensure the Bureau's mission is carried out for the overall benefit of the island. In 2019, the Bureau employed approximately 33 employees that supported five program divisions: Administration, Business & Economic Statistics, Socio-Economic & Coral Reef Initiative, Planning Information Program, and the Guam Coastal Management Program.

In partnership with NOAA, a Coral Fellow provides technical assistance to address specific coral reef management concerns such as climate change, landbase pollution and fishing impact on coral reefs as part of our coral reef mitigation and conservation efforts in conjunction with the Department of Agriculture.

Mission Statement

The mission of the Bureau of Statistics and Plans is to ensure Guam's resources are effectively used for the benefit of present and future generations by appraising, coordinating, preparing, and assisting in the development of a wide range of plans, policies, studies and statistics that further economic, social, land use, environmental and infrastructural goals, priorities and planning activities.



2020 Guam Census Kick-Off

On January 2019, the 2020 Guam Census Kick-Off Meeting took place with Governor Lou Leon Guerrero and Lt. Governor Josh Tenorio.

The Bureau of Statistics and Plans is designated lead agency for the 2020 Census on Guam. Data collection requirements will include the collection of demographic, social, economic and housing characteristics of Guam.



For 2019, exports averaged \$8 million. The top six export country's: FSM at 51%, Japan at 20%, Marshall Islands at 10%, Palau at 9% and Hong Kong at 9%,.



Fish Import & Export Data Collection and Monitoring System

The Fish Import and Export Data Collection and Monitoring System reported a total of 139,281 fish imports or \$2.2 million in air cargo imports and 891,640 or \$18.8 million in maritime imports from a variety of fish, crustaceans, mollusks and other aquatic fisheries in 2019.



Guam Coral Reef Resilience Strategy, finalized June 2019 and formalized by an Executive Order of Gov. Lou Leon Guerrero. GRRS is a strategic, living document designed to guide coral reef management efforts on Guam from 2019-2025. GRRS available at www. bsp.guam.gov.

The Bureau of Statistics and Plans applied and received ten (10) grant awards totaling \$3.3 million. BSP manages approximately \$24.5 million in both new and active grants. USDOJ, NOAA and DOI grants are awarded for a 2 to 3 year grant period with 90% passed to subrecipients to implement criminal justice projects, coastal and environmental initiatives.

Expenditures

The Expenditures primarily consisted of salaries and benefits. Operational expenditures from the General Fund included contractual, telephone and supplies, mileage reimbursement and subsidized rent for the Guam Developmental Disabilities Council (GDDC). Of the 33 employees of the Bureau in FY 2019, 19 were locally funded and 14 were 100 percent federally funded. A total \$919,775 in federal funds was used to cover personnel expenses.

Challenges in 2019:

- Additional program initiatives were absorbed from other agencies which caused challenges with limited staff resources. Despite additional program tasks, the Bureau met its mandates and additional program initiatives.
- Implementing a succession plan to build capacity and Institutional knowledge of critical program areas remains a challenge with funding constraints.
- Obtaining federal clearances in a timely manner on special award conditions such as congressional mandates, the Section 106 review process, permitting requirements, and GSA procurement to meet federal grant requirements and achieve full implementation of project activities.

Moving Forward

- ◆ Continue outreach programs such as the Guardians of the Reef and Eyes on the Reef to promote and advocate best management practices in protecting the island's coastal environment and balance of sustainable uses of resources and capabilities.
- Sustain and promote employee development, recognition and satisfaction.
