

Citizen Centric Report FY 2017





I Liheslaturan Guåhan or the Guam Legislature, is the lawmaking body of our government and sets policy for Guam. Fifteen Senators are elected at-large by island voters and serve two-year terms.

Inaugurated in January 2017, I Mina'Trentai Kuåttro Na Liheslaturan Guåhan is comprised of eight incumbent Senators and seven first-time lawmakers. For the last quarter of 2016 (the 33rd Guam Legislature) through Fiscal Year 2017, the members introduced 230 bills which addressed many issues including health, public safety, education, land, affordable housing, election reform, government finances, and government transparency.

Senators hold hearings which give members of the public the opportunity to provide input on bills and resolutions introduced which address various community issues.

Senators also host roundtable discussions, conduct oversight hearings, and participate in

legislative sessions.


OUR FINANCES

The Fiscal Year 2017 Budget for *I Liheslaturan Guåhan* was enacted via Public Law 33-185, which was passed by the 33rd Guam Legislature on August 29, 2016 and lapsed into law on September 10, 2016.

The Legislature approved appropriations for operations including personnel services for the Guam Legislature. This budget covers the fiscal year term of October 1, 2016 through September 30, 2017.

The Guam Legislature has received clean audits by the Office of the Public Auditor over the last several years.

Fiscal responsibility is practiced to ensure the legislature lives within its means. The fiscal team works diligently with all members of *l Liheslatura* to ensure the appropriate use of funds by the various offices and committees created by the Standing Rules.

Guam Congress Building

After nearly a quarter of a century, the Guam Legislature returns home to the historic Guam Congress Building. The building currently houses four senatorial



offices, Central Operations, Legislative Counsel, and the Office of Finance and Budget. The Speaker Antonio R. Unpingco Legislative Session Hall and I Liheslatura's Public Hearing Room are also part of the building.

Additionally, the Guam Congress Building is LEED (Leadership in Energy and Environmental Design) certified indicating recognition for its environmental performance and sustainability achievement. In the building, air conditioning units run on a consistent timer and the interior LED lighting fixtures are motion-sensored. A water system, which uses recycled water from rain and air conditioner condensation to supply the restrooms and building exterior, was also installed. These energy-efficient measures are anticipated to result in decreased utility costs. Contributions to the LEED certification came by way of the restoration of wood fixtures including the window shutters and hardware, railings and balusters, the chandelier light fixtures in the lobby and light casings in both the public hearing room and Session Hall.

Opened in 1949, the Guam Congress Building served as the Naval Government's home for the Judicial Center (courts) and the Legislative Branch for the island. The Guam Legislature is proud to be home and welcome all our people to visit.
