## The Citizen's Report FY 2014

**STRATEGIC GOALS:** The PEALS Board has established the following goals which provide the framework for the results it wants to achieve in furtherance of its mission:

- <u>Professional Qualifications</u>: Ensure the professional qualifications of those entering the practice by meeting minimum requirements for education, experience and examination, and ethics:
- <u>Practice Standards</u>: Establish regulatory standards of practice to those licensed and registered as professional engineers, architects, land surveyors and landscape architects;
- <u>Public Awareness</u>: Increase public awareness of Professional Engineers, Architects and Land Surveyors, and Landscape Architects, board's mission, activities and services;
- <u>Organizational Relationships</u>: To improve effectiveness of relationships with local and federal agencies and other organizations in order to further PEALS Board mission and goals;
- Customer Service: Improve the quality of customer service in all programs.

OPERATIONAL STRUCTURE AND DEMOGRAPHICS: The PEALS Board composed of seven (7) members, at least two (2) being female, to be constituted as follows: five (5) members who shall be registered under the provisions of 22 GCA, Chapter 32, and one (1) member of the general public. Except for the Director of Public Works, a member shall be appointed by the governor of Guam for a term of four (4) years. Of the five (5) registered professional members, two (2) shall be architects, of which one (1) may be a landscape architect, two (2) shall be engineers, and one (1) shall be a land surveyor.



#### **FINANCIAL DATA:**

The Board's main sources of revenue are fees for the issuance and renewal of registrations and fees for application from individuals who wish to take the engineering, architecture and land surveying examinations, and for applicants seeking registration by comity. These fees support the registration, examination, enforcement and administration programs, which includes processing and issuing registrations, statues, rules and regulations, and general operating expenses.




- 1. Registration based on graduation, experience and examination.

The Practice of Landscape Architect The Practice of Land Surveyor

Guam Law declares it unlawful for any person to practice, or to offer to practice engineering, architecture or land surveying in Guam as defined in the provisions of 5 GCA Title 22, or to use in connection with his name or otherwise assume, or advertise any title or description tending to convey the impression that he is an engineer, an architect or land surveyor, unless such person has been duly registered or exempted under the provisions of Title 22 of the Government Code of Guam.
