12	I, DERRICK MUNA QUINATA, hereby declare and state as follows:
13	1. I am the President of Monster Auto Corp dba Auto Spot ("Auto Spot"), the winning
14	bidder of Invitation for Bid: GSA-055-19, 14 Passenger ADA-Compliant Buses (the
15	"IFB").
16	2. I am familiar with the IFB and the Appeal lodged with the Office of Public
17	Accountability by Soderholm Sales & Leasing, Inc. ("Soderholm").
18	3. I am competent to testify as to the matters asserted herein.
19	4. Based on my review of the Appeal, Soderholm failed to present evidence proving that it
20	submitted a bid that was compliant with the bid specifications.
21	5. Instead, the evidence proves that Solderholm submitted a bid that did not comply with
22	the bid specifications. Specifically, the bid required the wheelchair lifts to be located
23	curb side beside the front entrance but Soderholm submitted a bid for rear facing
24	wheelchair lifts.
