1. The Pre-Hearing Conference will focus on expediting the disposition of the appeal and may include:

- 1 a. Formulation and simplification of issues;
- 2 b. Possibility of obtaining admissions of fact and of documents that will avoid
- 3 unnecessary proof, stipulations regarding the authenticity of documents, and advance rulings
- 4 from the Hearing Officer on the admissibility of evidence;
- 5 c. The avoidance of unnecessary proof and cumulative evidence;
- 6 d. The identification of witnesses and documents, the need and schedule for
- 7 filing and exchanging pretrial briefs;
- 8 e. The disposition of pending motions;
- 9 f. The need for adopting special procedures for managing potentially difficult
- 10 or protracted actions, complex issues, multiple parties, or unusual problems;
- 11 g. Establishing a reasonable limit on time allowed for presenting evidence; and
- 12 h. Such other matters as may facilitate the just, speedy, and inexpensive
- 13 disposition of the action.
