Pursuant to 2 GAR Div 4, Chap 12, §12104(3), please submit one complete copy of the procurement record for GIAA-FY98-08-02 and RFP-005-FY11, as outlined in 5 GCA Chapter 5, §5249, to OPA by **Wednesday, March 16, 2011**, five working days following receipt of this notice of appeal; and one copy of the Agency Report, as outlined in 2 GAR Div 4, Chap 12, §12105, by **Wednesday, March 23, 2011**, ten working days following receipt of this notice of appeal. When filing all other required documents with our office, please provide one original and two copies to OPA, and serve a copy to the Appellant (protesting vendor).


