Hi Paul,

As you may be aware, GSA lost an appeal involving the solicitation for fire trucks, custom cab pumpers and urban/wildland interface pumpers. One provision of the IFB that the Public Auditor ruled must be changed is the provision requiring the manufacturer to bring two GFD personnel to the factory, once at the beginning of the construction of the trucks, and once at the conclusion, presumably to confirm that trucks will not be shipped to Guam prior to being approved by GFD.

I believe GFD will want to ask for a reconsideration of this decision. Do you have any information about industry standards concerning this type of trip to the factory concerning the construction of expensive custom machines, etc.?
