THESE MATTERS came before the Public Auditor on February 12, 2013 pursuant to a joint stipulation and order requesting for a continuance of hearing and other deadlines. Despite the mutual agreement by all parties, the Public Auditor hereby DENIES said request and the deadlines and hearing dates on the Scheduling Order filed on January 16, 2013 still stand. The award of the health insurance contract is of critical importance to the employees and retirees of the Government of Guam. Further delay in reaching a resolution is not in the best interest of the employees and retirees and will not be permitted. Deadlines and hearing dates remain as follows:

- 1. Stipulation of Facts and Facts in Dispute shall be filed no later than February 19, 2013.
- 2. Submission of hearing exhibits that are not part of the procurement record shall be filed no later than February 26, 2013.
- 3. Each party shall submit a hearing memorandum no later than February 26, 2013.
- 4. The Formal Hearing scheduled for January 21 through 23, 2013 had been rescheduled to March 5 through 8, 2013 at 9:00 a.m.
- 5. TakeCare's motion to dismiss will be addressed at the Hearing.
