In a May 18 Pre-Hearing conference the Attorney for Appellant, Teal Pacific, requested that Public Auditor Doris Flores Brooks disqualify herself from rendering a decision on the above-captioned appeal. The request was based on information the Public Auditor disclosed to the parties which communicated (1) that Public Auditor and her husband have a doctor / patient relationship with Dr Nathaniel Berg, a principal of the Appellant and (2) that the Public Auditor and her husband had a casual acquaintance with the Appellant's other principal, Mr. Siva Karuppan. The Public Auditor first encountered Mr. Siva Karuppan as a patient when Mr. Karuppan and her husband were under going cancer treatment at Cedars Sanai Medical Center in

Los Angeles from December 2007 to January 2008. While the Public Auditor does not believe the relationship with Dr. Berg and Mr. Karuppan will prejudice her actions in this matter, pursuant to the authority of 2 G.A.R. §12601 and 5 G.C.A. §5480 the Public Auditor has determined to recuse herself from hearing the above-captioned appeal and hereby orders the appeal be DISMISSED.
