The approved reimbursement schedule for each application year was Seventy-Four Percent in 2011; Eighty-One Percent in 2012; and Eighty-Two Percent in 2013. GDOE's E-Rate applications did not request discounts for services below or above 1000Mbps.

5. That between July 2011 and August 2013, GDOE did not receive USAC reimbursements for WAN services in GDOE schools.
