On April 15, 2008, Guam Cleaning Masters (GCM) filed an appeal with the Office of the Public Auditor (OPA) relative to University of Guam (UOG) Bid No. P11-08, "Student Housing Custodial Services."

Following the submittal of the Agency Report on April 30, 2008, a Stipulation Staying Appeal was filed by the attorney for the Appellant. A hearing regarding the Stipulation Staying Appeal was held on May 12, 2008 at OPA.

On May 16, 2008, OPA issued a notice of pre-hearing conference scheduled for June 11, 2008 relative to the above referenced appeal.

Pursuant to the Appellant's June 10, 2008 Motion to Continue and the Appellee's non-opposition thereto, the pre-hearing conference scheduled for June 11, 2008 was rescheduled to July 2, 2008.

On June 20, 2008, the attorney for GCM, the Appellant, filed with the OPA a Stipulation of Dismissal based on the agreements reached by UOG and GCM.

The Appellee, UOG, signed and concurred with the stipulation of dismissal that stated:

UOG and Appellant GCM have resolved the legal issues underlying the above referenced appeal by awarding the disputed bid to the Appellant, GCM.

As such, the Public Auditor does hereby order the above-captioned appeal DISMISSED without prejudice pursuant to 5 G.C.A. §5425 and the agreements reached in the stipulation for dismissal.
