MARIANAS VARIETY-GUAM, an Interested Party in the above-captioned appeal, by and through undersigned counsel, hereby requests the disqualification of the hearing officer. This opposition is brought pursuant to 5 GCA § 9222 and supported by the accompanying affidavit, Memorandum of Points and Authorities and any additional evidence which may be adduced at the hearing held on the matter.

MEMORANDUM OF POINTS AND AUTHORITIES

Appellant Guam Publications Inc. appeals the award of a contract to publish legal notices and raise issues relating to the cost of publishing and whether the publishing legal notices in the Marianas Variety complies with Guam law. Section 9221 provides that "[a]ny party may request the disqualification of any hearing officer or agency member by filing an affidavit prior to the taking of evidence at a hearing, stating with particularity the grounds upon which it is claimed that a fair and impartial hearing cannot be accorded." 5 GCA § 9222 (2005). In this case, it appears that the

hearing officer has an existing and ongoing business relationship with Appellant. Specifically, the hearing officer appears to advertise his private law practice in Appellant's newspaper, the Pacific Daily News, on a weekly basis, approximately three (3) days a week. See Affidavit of Leevin T. Camacho, Exhibit A. Based on this relationship, the hearing officer's impartiality might reasonably questioned and, therefore, Marianas Variety requests his disqualification.

Furthermore, the hearing officer has published legal notices in the Marianas Variety for his private law practice. See Id., Exhibit B. This is significant because one of Appellant's contentions in this appeal is that the Marianas Variety is not a daily newspaper of general circulation and cannot be awarded the bid as a matter of law. Although focusing primarily on the requirement that notices be placed in a "daily" newspaper, Appellant argues that "the PDN is the only newspaper of general circulation on Guam." Appellant's Comments in Response to Agency Report, p. 4 (emphasis added). The hearing officer, by publishing legal notices with the Marianas Variety, has already rejected Appellant's position on this issue. Thus, a fair and impartial hearing on all of the issues raised in this appeal cannot be held.

CONCLUSION

Based on these considerations, Marianas Variety does not believe a fair and impartial hearing can be held, and, therefore, requests that the hearing officer be disqualified in this matter.


