Protest of Intent to Award Contract to Guam Educational Facilities Foundation, Inc. ("GEFF")

In support of the Department of Public Works' ("DPW") Notice of Decision dated June 8, 2016, and Notice of Decision, dated June July 15, 2016, officially denying the second and third protests made by Core Tech International Corp. ("Core Tech") concerning the above referenced Request for Proposal ("RFP").

The procurement process has encountered a number of problems created by outside influences and situations and a number of protests by losing proposer Core Tech, all of which have resulted in hardship for the residents of Guam, in particular the students, staff and administration of Simon Sanchez High School and Guam's other public schools. Public Law 28-45, Title 1 G.C.A., Chapter 7, Section 715, provides that students attending the Department of Education should be educated in a healthy, safe and sanitary learning environment. Section 29(b) of the Guam Organic Act provides further: "The Government of Guam shall provide an adequate public educational system of Guam, and to that end shall establish, maintain, and operate public schools according to the laws of Guam."

Public Law 32-120, the *MA KAHAT ACT* OF 2013 and Public Law 32-121, also known as the *MA KAHAT ACT* OF 2013 (collectively the "Act"), which authorized the RFP added new Chapters 58D and 58E, respectively, to the Guam Procurement Code. Public Law 32-120 states

in the Legislative Findings and Policies that "I Liheslaturan Guahan finds that Simon Sanchez High School faces the combined challenges of deteriorating conditions, out of date design, and overcrowding. These combined deficiencies impair the quality of teaching and learning and contribute to health and safety problems for staff and students." In addition, the Legislature's urgency in moving forward with the project is documented in Section 58D105 in which it states the RFP "shall be issued within thirty (30) days of enactment of this Act for the renovation or construction of a new Simon Sanchez High School on the existing site, …". The Department of Education agrees with and supports these legislative findings, which it notes were made over a year and a half ago, and affirms that the need to replace Simon Sanchez High School is urgent and immediate.

It is clear that problems associated with the ongoing delays in completing a procurement to resolve these critical educational needs, that being the reconstruction of Simon Sanchez High School and the development of a comprehensive capital improvement plan to address past due repair and maintenance needs for Guam's other public schools, are having a direct adverse effect on Guam's public middle and high school population. It is obvious that the procurements authorized by the Act, which was unanimously authorized and mandated by the Guam Legislature and is also a top priority for the Governor and Lt. Governor of Guam, is of substantial interest to Guam and should *immediately* move forward.

The Department of Education hereby asserts that, pursuant to Title 5 GCA §5425 G (1), the awarding of the contract to the top ranked offeror without delay is necessary to protect the substantial interest of Guam.

## Buenas Yan Hafa Adai:

Concerns relating to ongoing delays related to the reconstruction of Simon Sanchez High School have existed since the time the unsuccessful offeror filed its June 23, 2016 Notice of Appeal to the Office of Public Accountancy ("OPA"). The Appeal was based on the department's denial of the offeror's second protest dated May 27, 2016, in this procurement. These concerns significantly increased with the offeror filing yet another protest on July, 15 2016, which was also denied. Unsuccessful offeror's third protest necessitated consolidation of the second and third protests and rescheduling of Appeal hearing dates.

Pursuant to the authority provided me under 5 GCA Section 5425(g)(1), I have decided to immediately move forward with a determination that "the award of the contract without delay is necessary to protect the substantial interests of the territory" needed to lift the stay of the procurement and to finalize an Indefinite Quality/Indefinite Quantity contract AS SOON AS POSSIBLE.

While discussions have been held the past several weeks, it is my determination that the reconstruction of Simon Sanchez High School can't be delayed any further. Accordingly, I would request that your agency submit its detailed Statement of Interest by mid afternoon tomorrow, Tuesday, September 13, 2016. Upon receipt I will finalize the department's Statement of Interest and meet with the Guam Attorney General AS SOON AS POSSIBLE. If all is in order the Statement of Interest will be compiled by our legal advisor for presentation to the OPA in the Appeals process.

Thank you for your continuing assistance.

Dear Director Benavente:

The purpose of this letter is to express GEFF's concern that the continued delays caused by CoreTech's unwarranted protests and appeals will have a material detrimental impact on the reconstruction of Simon Sanchez High School and the repair of the other GDOE schools. The GEFF Plan of Finance uses a creative combination of a direct USDA Community Facility Loan ("USDA CFL"), tax-exempt certificates of participation and project equity. This "hybrid" plan of finance is designed to take advantage of the historically low 2.75% interest rate now available with a direct loan from the USDA CFL program supplemented with tax exempt financing that is 1% lower today than a year ago. As a result of the favorable financing rates and unique GEFF structure the annual savings to the Government and people of Guam is approximately \$1,296,000 per year or \$38,879,000 over the thirty-year lease term. However, these savings are likely to be lost unless GEFF moves quickly to lock down this opportunity with the USDA.

As outlined in our letter to you dated July 8, 2016, the USDA approved GEFF's loan pre-application and requested that we submit a formal application by August 31, 2016 in order to qualify for funding in the federal government's 2016-17 fiscal year which begins on October 1, 2016. At considerable time and expense, GEFF completed and submitted the formal loan application to USDA on August 22, 2016 to preserve this financial opportunity. We are concerned that unless there is a timely resolution of Core Tech's appeal and we can submit a signed IDIQ prior to the beginning of the US Government's fiscal year then the loan application will be considered incomplete and funding allocated to other competing projects across the country.

Furthermore, recent statements by the U.S. Federal Reserve Board suggest that an increase in interest rates is near. Any such action will raise the costs of borrowing on both USDA and tax exempt financing; however, one particular benefit of the USDA program is that once awarded the interest rate is fixed for the term. Our ability to lock not only the commitment but also the interest rate is another compelling reason to seek an expedited solution to the appeal.

Additionally, the lowest interest cost for interim construction financing is available by using a Bond Anticipation Note (BAN) for the USDA portion of the project cost. The USDA customarily provides permanent loans for completed facilities and prefers not to provide construction financing for projects such as SSHS. Stifel Nicolaus, GEFF's underwriter, has completed many similar transactions and is highly confident that short term construction notes can be issued at attractive interest rates in the current markets providing even greater savings.

The monetary benefits of GEFF's financing plan and the current rate environment are over \$38 million (\$23 million on a present value basis) and out weight by far the frivolous issues raised in Core Tech's appeal. We encourage the Government to take the actions necessary to enable the IDIQ to be executed so that the loan application and plan of financing can be executed under these favorable terms.

We hope that our expression of concerns and the risk of delay are duly considered. GEFF is committed to doing what we can to move this important project forward in a manner that will provide the best value for the people of Guam. Please feel free to share our concerns with the other Committee members.

This letter is intended to provide you with additional information to support a determination, per Title 5 GCA §5425(g)(1), that moving forward with the RFP Project no. 730-5-1055-L-YIG Lease Financing for Design, Renovation, Rehabilitation, Construction and Maintenance for Public Schools (the "Project") as awarded is in substantial interest of the Island of Guam. While we believe that the Guam Department of Education ("GDOE") has provided arguments in support of moving forward, there are a number of municipal market factors to take into consideration.

The Guam Economic Development Authority ("GEDA"), as Central Financial Manager, is charged with ensuring that the perception of Guam as a viable and worthy investment option is maintained through continued communication with all market stakeholders. As Guam is at a critical juncture in the market, and in light of the recent Puerto Rico Bond defaults, we believe that the potential for further delay or litigation may be detrimental to Guam's outlook in the capital markets for the following reasons:

#### Low Interest Rate Environment and Market Volatility

Notwithstanding the impact of the delay on Guam's school children and their access to adequate educational facilities, the municipal market rates have been dropping significantly this year, attributed to all time low, but volatile, treasury rates and the quick market rebound since the announcement this past June of the United Kingdom's intent to withdraw from the European Union, commonly know as "Brexit". Executing the financing now would directly impact the Government, since lower rates would mean lower borrowing costs for the project. An additional risk is that there is strong market anticipation that the Federal Government will begin to increase interest beginning in December 2016.

#### Increased Costs as a Result of Delays

Another consideration is the cost of the delays due to the protest and potential litigation. Construction costs and labor costs are rising while the timeframe in which the school must be constructed is shrinking. This may result in a higher cost to construct Simon Sanchez High School ("SSHS") and make critical repairs to the other schools in a tighter timeframe as more workers and more labor hours would be required to complete the project in time for the required school year. This will more than likely cause major disruptions and inconvenience for the school administration in planning the transitions from the old facility to the new facility, for instance in the case of SSHS, or during the time needed to make rushed repairs at the other school facilities.


