Please be advised that Pacific Data Systems, Inc (PDS) filed an appeal with the Office of Public Accountability (OPA) on October 19, 2012 of the General Services Agency (GSA)'s response to PDS' protest relative to the procurement solicitation Invitation for Bid No. GSA-064-11: Telecommunication Services. OPA has assigned this appeal case number OPA-PA-12-017.
