On July 29, 2014, a Pre-hearing conference was held before Public Auditor Doris Flores Brooks and Hearing Officer Peter C. Perez, Esq. Bill R. Mann, Esq. appeared on behalf of appellant, Pacific Data Systems, Inc. ("PDS") along with PDS President, John Day. Minakshi V. Hemlani, Esq. appeared on behalf of Purchasing Agency, Guam Visitors Bureau ("GVB"), along with GVB Deputy General Manager, Jon Nathan Denight. At said hearing, the Parties were ordered to brief the following issues: (a) whether or not GVB had jurisdiction to entertain PDS' Protest in light of PDS' pending appeal in *In the Appeal of Pacific Data Systems, Inc*, OPA-PA-14-003; and (b) whether or not PDS' instant appeal was timely filed:

- 1. PDS shall file its brief no later than August 1, 2014.
- 2. GVB shall file its brief no later than August 6, 2014.
- 3. PDS may file a reply brief no later than August 8, 2014.
