In planning and performing our audit of the financial statements of the iLearn Academy Charter School, Inc. (the “Academy”) as of and for the year ended September 30, 2023, in accordance with auditing standards generally accepted in the United States of America, and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States, we considered its internal control over financial reporting (internal control) as a basis for designing our auditing procedures for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Trust’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Trust’s internal control.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity’s financial statements will not be prevented, or detected and corrected on a timely basis. A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

During our audit, we noted the following other matters that should be brought to your attention:

Base Rent Payment

Condition:

During our examination of the monthly lease invoices from The Learning Institute (TLI), we noted that the Academy paid base rent amounts that were higher than what was stipulated in the lease agreement. Total overpayment for the fiscal year 2023 amounted to approximately \$22,000.

Recommendation:

We recommend the Academy adequately review the invoices for any departure from the agreement to avoid any disputes or poor cash management.

Lease Agreement (Update of Prior Year Comment)

Condition:

During our examination of the monthly lease invoices from TLI, we noted that the Academy did not receive supporting documents for other billed charges pertaining to utilities, communication, trash food services which totaled \$789,600 for the entirety of the fiscal year.

Recommendation:

We recommend the Academy to request appropriate supporting schedules and documents from TLI to ensure that amounts charged to the Academy are reasonable.
