## Our Purpose

The Guam Commission for Educator Certification (GCEC) was established by Public Law 29-73 on May 15, 2008. The Commission is governed by a seven (7) member Board of Commissioners appointed by the Governor and confirmed by *I Liheslaturan Guåhan*.

GCEC certifies educators employed by the Guam

Department of Education,

DODEA and private schools.

Over 3,000 educators have about 5,000 certificates.

Some educators hold more than one or more certificates.

Others have moved off-island but still keep their

certificates current.


