Introduction to the OAG

In this report, we showcase the work done prior to the inauguration of Attorney General Douglas B. Moylan, who took helm of the office in January 2023, and will provide a glimpse into the promises he swore to keep when he was elected as attorney general.

The Office of the Attorney General (OAG) is the largest law firm in the Western Pacific. Our job is to uphold the rule of law for both the people and government of Guam.

As the "toughest law enforcers," we prosecute criminals and work with law enforcement counterparts to keep our homes and communities safe. We work to better serve low risk juvenile offenders through rehabilitation programs, and bring justice to individuals who inflict undue harm and danger upon children placed under the care of Child Protective Services.

We also protect consumers from scams and other deceptive practices like price gouging during typhoons and other natural disaster or emergency situations.


Additionally, we represent the government in legal battles, dispense advice to them through Opinions and Legal Memorandums, and bring cases to court when the government is an interested party.




FY2022 General Fund Appropriation & Expenditures

The OAG is responsible for managing the Victims of Crime Act (VOCA) federal grant which funds organizations that provide direct services to victims of crime. The Office received a total of \$908,175.00 for victim assistance-related funding, and \$45,000 for victim compensation reimbursement. These funds have yet to be divided among the subrecipients,

Looking Ahead: A Message from The Eagle's Nest

Hafa Adai to the People of Guam,

Thank you for placing your trust in me, and reelecting me as Guam's attorney general. I swore to keep the promises I made when I ran for Office, and so far, I am keeping those promises.

I first and foremost promised to put criminals in prison, and we are. We changed our charging procedures, and as a result, more offenders are held in jail while they await trial.

I also promised to pursue government corruption, and we have. I've launched a special unit and assigned an attorney and investigators specifically to run it. In fact, we have already charged cases in court and are actively investigating other potential matters.

"Our attack upon the meth epidemic has been to stop the catch, release and re-offend problem and also to begin to do deterrence campaigns showing photos and examples of those convicted, ... that if you possess, take or distribute meth that our juries are convicting, and we are seeking actual jail time"



On the preemptive end, we installed static and electronic billboards in order to deter crime by publicly displaying the faces of convicts. With this, I hope to send a clear message to the public that if you commit a crime, we WILL charge you.

I also intend to expand this deterrence method into a public service campaign to relay information to the community about what they can expect out of my Office, and to uphold the promises I swore to when I took my oath as the attorney general for the second time.

Within the first six months of my tenure in FY2O23, we boosted awareness about parents' need to "love your kids," and hold both custodial and non-custodial parents accountable for the healthy growth and development of their children. You can expect to see me, my staff, and Eric the Eagle out and about in our community, expanding both our presence and public knowledge of the services we provide.

In closing, I look forward to continue serving as YOUR Attorney General.


